All Vendors:

1. The Backcountry Horsemen of California 2018 Rendezvous Committee may inspect vendors at any time. The Backcountry Horsemen of California and Committee reserves the right to shut down any booth for non-compliance with any applicable law(s), operating outside of the requested and approved function(s), or operating in a disrespectful, immoral or unethical manner toward any patron, official, competitor, vendor, city employee or any other attendee of the event.
2. Event is at PASO ROBLES EVENTS CENTER 2198 Riverside Ave. Paso Robles, CA 93446
3. Vendor booths are located outside under covered arena. As the Rendezvous Committee cannot predict the weather, we ask all vendors to plan accordingly for the weather.
4. Vendors requiring electricity will need to provide an extension cord at least 100 feet long. Vendors provide all their own tables and chairs for set up.
5. Booths must be staffed 9:00 am to 5:00 pm both Friday and Saturday, and 9:00 am to 3:00 pm Sunday.
6. Set up begins at 11:00 am on Thursday. Tear down may begin after 3 pm on Sunday.
7. The grounds must be cleared of all vehicles after set up and one hour prior to opening.
8. NON-PROFIT ORGANIZATIONS must have proof of non-profit status.
9. Do not tear down prior to close of event.
10. TCSN will provide WIFI for vendors for 34.95 per vendor for length of event
11. We have limited corner spaces available. first payments, gets the spots.
