



THE 29TH ANNUAL RENDEZVOUS March 18 - 20, 2016

Calavaras County Fairgrounds

We are gearing up for the **29th Annual Rendezvous**. This will be our second year hosting the Rendezvous in Angels Camp. We'll be gathering the weekend of March 18th, 19th, and 20th.

If you haven't been to Rendezvous before, let us tell you what you can expect.

BCHC member volunteers will arrive on the Wednesday before the event to start setting things in motion. We'll be setting up corrals to stable all the equine that will be arriving for the weekend and lining out all the camping and vendor booth spaces. We'll get the BCHC Office, the Registration Trailer, and the signage set up. On Thursday, the vendors will set up their booths so everything will be in place when the event starts at 9:00 AM on Friday.

During Rendezvous, dry camping is available on-site at the Calaveras County Fairgrounds, known by most as the "Frogtown Fairgrounds". (The Jumping Frog Jubilee has been a part of the Calaveras County Fair since 1893, which is one of the longest running consecutive events in the State of California. A walk down historic, Angels Camp's Main Street shows you the names of winning frogs throughout the years.) If you're not into dry camping, there is an RV Park adjacent to the fairgrounds and hotels/motels in town. You can also come for just one of the days - but with so much going on, you might have trouble deciding which day!

## President's Page

Most of California has been getting welcome rain and snow. It looks like we will have a good water year. One of the results of the drought followed by the wet windy weather is down trees.

On a recent ride in the coast range I came across seven downed oaks in a two mile section of trail. Units should plan to recon, locate and working with the appropriate agencies, log out the down trees on our trails through the spring and summer.

Fortunately the long waited for national saw policy is now scheduled to be signed in March. This will allow a much easier certification process for sawyers. This policy will cover both crosscut and chainsaw use. We will keep members informed when the policy goes into effect, and when and where saw certification clinics will be held.

Yosemite National Park is conducting its new wilderness steward plan. http://www.nps.gov/yose/getinvolved/wsp.htm. This is critical for all stock users. There is a small but very vocal minority of users who want stock use restricted. Combine this with the apparent anti stock proclivity of the park superintendent and stock users face a serious threat, closure of trails, closure of meadows, restrictions on numbers, etc.

Randy Rasmussen our BCHA Wilderness Advisor, working with Troy Patten has written an excellent letter sent



to the park as part of the scoping process. In it they worked to head off all possible arguments against stock restrictions. They have asked that the park base all its decisions on sound science, not emotional declarations by that small anti stock minority. They have also asked the park to use us as partners in planning and implementation of stock related facilities and activities. I imagine we members will jump at the chance to help, camp and ride in the park in support of park management.

Jacque Murphy, our web guru and all around tech queen brought up an interesting idea at our exec board meeting. Her unit has used the Facebook 'boost' advertising for unit events, and significantly increased interest in the unit events. You may want to consider doing the same for your unit events, the cost is minimal the effect can be 'viral'.



I built a set of pack boxes to carry chain saws, gas, oil and accessories, based on a set built by Lee Roeser. I made mine out of plywood. I am going to contact our local high school FFA groups to see if they have members who would like to construct metal boxes, and also become part of BCHC. The pack box construction could be a lever toward gaining younger members. This is something I think all units could do.

And finally, Rendezvous at Angels Camp promises to be an excellent event, it is well worth attending. I hope to see you there.

### PARK WATCH REPORT

It is a bright, sunny, crystal clear day in the Sierra foothills and a perfect time for riding and reflecting. Just you and your horse and nature. It is a glorious experience. Then, **KAH-BANG!** You find yourself lying on the ground and your horse is stampeding off down the trail. What just happened?

On January 3, 2009, two equestrians were riding at Folsom State Recreation Area (Folsom, CA) on a designated and posted horse only trail. They were confronted with 3 motorcycle riders, their horses bolted. Both riders were thrown and sustained severe head injuries, bruised ribs and general trauma.

"Toby", a 4-year –old Appaloosa/Quarter Horse, got only ½ mile down the trail but in that short distance he experienced injuries so severe he was euthanized on the spot. The other horse, "Bailey", a 20 –year-old Morgan, traveled more than 5 miles from the incident site and was eventually located, thankfully, uninjured.

The Folsom Lake State Recreation area is located in a semi-urban area and has designated riding areas for horses, mountain bikes, 4-wheel OHV and hiking. Even so there is conflict from time to time and this incident became the flash point for change in the Sierra Foothills of California. A determined group of park volunteers, bird watchers, mountain bike riders, hikers, equestrians and park management convened. They set their sights on conflict prevention and they would start by improving connectivity between trail users and park management.

This Ad Hoc group wanted a simple and convenient method for passing information between trail users and park management. It had to be available 24/7, simple to access and use, remain unobtrusive and available to everyone. This solution had to target safety issues and work to address problems preemptively.

The motorcycle riders had entered the trail system from private property through a cut fence. With the benefit of 20/20 hindsight it is plausible that an intact fence might have denied the motorcyclist access to the horse only trail. Local equestrians were aware of the cut fence, but in the Sierra foothills public land is managed by the US Forest Service, Bureau of Land Management, CA State Parks and multiple cities and counties. Whose jurisdiction did this fence fall under?

The web-based service now known as ParkWatchReport was born out of the Folsom Lake tragedy and a direct line of communication between land managers and the trail-using public.

The FREE phone app provided by ParkWatchReport can take a report from a trail user and forward it to the appropriate land manager in 2 minutes or less. It is available 24/7 and 365 days a year. The app automatically records the date, time and the GPS coordinates of the report site. Site photos can be uploaded (a picture is worth a thousand words to a land manager) and it records a detailed (or brief) description of the condition being reported. Hit "SEND" and the report is forwarded real time to the land manager with jurisdiction based on the GPS coordinates.

Trail users can now report cut fences, trails blocked by fallen trees, weather or trail use related erosion, dangerous trail conditions, or trails being used illegally no matter where they are in the US and Canada. At https://www.parkwatchreport.com/ there is a list (which is rapidly expanding) of parks that currently subscribe to ParkWatchReport in order for their park to be featured but the actual reporting system works independently. A report can be filed from any trail anywhere anytime.

As trail riders you are already the "boots on the ground". With ParkWatchReport downloaded on your smart phone you become a vital part of the day-to-day communication exchange that has added a new and significant level of safety to all trails.

#### ANTELOPE VALLEY UNIT ANNUAL REPORT

#### Rides:

- The year started with a training ride in Griffith Park. The weather was clear and beautiful. We could see in all directions, and clearly see downtown LA. It was a great opportunity to desensitize our backcountry equines to tunnels, bicycles, the freeway, and a wooden suspension bridge over the LA River, hikers etc.
- In March we rode out of Orcas-Gabrieleno Equestrian Center (Hansen Dam) in the LA Foothills, where there was lots of water to practice in.
- Our annual beginners' (new members) pack trip to the Golden Trout Wilderness was canceled this year due to heavy smoke causing unsafe air quality in the Trout Meadows.
- We have two more rides scheduled this fall.

#### Public Rides: Membership Drive and Education

- In April, we had the first of three public rides to promote membership and provide education. Due to the drought and lack of poppies, our annual Poppy Ride was moved to Leona Valley. #### HIGH SIERRA UNIT ANNUAL REPORT

Hi! 2015 has been a busy year for our unit. We have undertaken many projects to help preserve and promote backcountry use. We started out the year by setting our priorities and unit goals. When a new year starts so are the lists of High Sierra's things to do. This year we emphasized backcountry access on public lands and our search of where and when to have our Trail Rides. With each season there is a ride planned by Bill See and crew, and everyone looks forward to going to a new destination filled with good times, food and education. This has also been a successful way to get new members. With each ride there is usually a speaker invited or a topic to discuss. Whether it being a local veterinarian, a local Pack

Team, the discussion of Saddle Fitting or an up and coming Work Project there is always something to come away with.

Board Member Dena Flores successfully organized a Play day. Many enjoyed this and there are always members asking when the next one will be. Bill See also sponsored a tack swap to give members the opportunity to get rid of any surplus gear they may have accumulated.

This year our unit emphasized outreach and public awareness by participating in the Woodlake, Porterville, and Bishop Mule Days Parades. We spread the message of gentle use and leave no trace principles while showcasing working pack strings that allowed the public to see some of the tools and techniques we use in the backcountry. We were rewarded for our efforts by winning awards in the Woodlake and Mule Days Parades

Our Public Lands Committee, headed by Dick Cochran, has been an invaluable asset to our unit. They have spent numerous hours in meetings with Park or Forest officials and numerous hours of their own time researching issues, with one intention, preserving our historic right to use stock in the backcountry. They have been passionate and staunch advocates of representing our cause to the public agencies that manage our local resources. SEKI has recently published their Wilderness Stewardship Plan, and implementation ofthat plan is being watched closely. The Sequoia National Forest is redoing their Forest Plan, and that process is being followed and commented on as well.

The Work Project Committee has been equally committed to putting our goals into action. They have helped organized bear box placement, and provided extensive resupply logistic support to American Conservation Experience work crews in Sequoia National Park and an FFA pack team getting their first taste of the backcountry. We want to show our agency partners that we can be depended on to help with the actual work of maintaining our precious resource.

Manning an informational booth at the Woodlake Lions Roping event has also emphasized Backcountry Education and our commitment to its preservation. We still have another ride, play day, and Fall Festival coming up to round out the year. I am proud of our members and what they have accomplished this year. They deserve lots of thanks and praise.

#### EASTERN SIERRA UNIT ANNUAL REPORT

The Eastern Sierra Unit had three work parties this year so far.

They worked in the Red's Meadow area near Mammoth clearing trail with the PCTA.

They took a large party into Black Rock and split into two groups to clear trail in the Inyo Forest. This was a four day trip.

Another smaller work party returned to Red's Meadow to do some work there.

The Unit also held its annual fund raiser at the Elks Club with a catered dinner, live entertainment, silent auctions, and calendar sales.

#### **LAKE-MENDO 2015 UNIT REPORT**

2015 was a very productive and also a devastating year for Lake County Lake-Mendo BCHC Unit.

To start off we installed a much needed Water Tank and Trough at the Boggs Mt. Horse camp and made repairs to the rock fire ring and table. Unfortunately we do not know the condition of this tank or trough given the recent Valley fire in Cobb Mt. and Middletown. We can only hope it survived. This area has been closed indefinitely and there is no time frame for re-opening. We have lost one of the best riding areas in this County due to this fire. The Cowboy Camp, Judge Davis, and Cache Creek areas have also been damaged by fires but are open. They are in need of erosion and fire related work.

We have furthered our alliance with BLM and Mendocino National Forest with continued trail clearing and work in the Cache Creek at the Redbud Tail, Yolla Bolley Wilderness, Snow Mt. Wilderness and Knoxville Fish & Wildlife recreation areas. The redbud trail was totally blocked and a work day cutting down trees opened this trail to hikers including the 'Secretary of the Interior, Congressmen Mike Thompson, Barbara Boxer's Aids, and Tuleuyome Members. Over 15 miles of blocked trails from down trees were also cleared in the Snow Mt. Wilderness. At the Summit Springs trail head the blocked water line to the horse trough was also repaired. The members have continued efforts to replace signs in the Green Springs area of the Yolla Bolleys installing 4 signs on one pack trip. A list has been supplied to the Forestry Dept. for signs needing replacement in the Snow Mt. Wilderness. The signs are being made and installing them will be one of our upcoming work projects.

With all the fires in Lake County, the ROCKY FIRE, JERUSALEM FIRE, AND THE VALLEY FIRE we have offered our assistance in the areas affected including Cowboy Camp, Judge Davis Trail Head, Cache Creek, and Knoxville Wildlife Area. Erosion control, trail clearing, and culvert replacements will be needed and BLM sees this as a three year project. Substantial help will also be needed in the Boggs Forest with trail clearing and proposed replanting of the forest. This will also be a very long term project. Friends of Boggs recently had bike bells made with their name and Lake-Mendo Unit, to pass out. This project is also on hold. We understand this area is planning clear cutting and logging to clean up the fire damage. We may need repairs to the outhouse and water system recently installed.

Finally the Lake-Mendo Unit is very proud to have had 3 members form our Unit selected to attend the 2015 Wilderness Rider Program, Chris Vallerga, Paul Villanueva, and myself. For such a small Unit we feel very fortunate to have such a large interest in this program and are striving to promote the 7 LNT principles and interact with the public.

Our ongoing and future activities include involvement with the Tuleyome Group in forming the Berryessa Snow Mt. Trials Initiative which our Pres. & Public Lands VP Paul Villanueva has been selected to be on the core group heading this initiative. We have been requested by US Forestry to be involved with the planned introduction event with US. Forestry and BLM in partnership with BCHC to commemorate the new Berryessa Snow Mt. Monument. We have been asked to participate in this event and supply Stock to pack in dignitaries for an overnight pack trip into the Snow Mt. Wilderness from Summit Springs and speak on our involvement in the monument area at the dedication ceremonies.



- -in the beginning BCHA did not want states east of the Mississippi in the organization. The east coast units have been very cooperative, as they can get to Washington DC to testify on issues.
- -Randy Rasmussen has been a great help with trails
- -Kevin McCarthy (from Bakersfield) understands land issues

#### Information from Pete Kriger:

- -he is a conduit of information from BCHA to all units and back to BCHA
  - -there are monthly teleconferences- Tues and Thurs.
- -new president- from Wyoming former BCHA Treasurer. His wife takes care of the website.
- -BCHA Sacramento Meeting: thank you to Mid Valley and Mother Lode Units. We were praised for our presentations by Ken Graves and Michael Morris. Dr. Rob Atwell's presentation: water borne pathogens showed the small chance they are passed by equines and 100 times more likely from squirrels. Had several entertaining talks:


Oh, did I mention a buckle?? A CHAMPION buckle will be given to the low point rider in each class. Prizes will also be awarded through 5th place.


#### **Future Opportunities**



#### SUTTER BUTTES UNIT ANNUAL REPORT

End of the year Report. Submitted by Bob Gage, Unit President, 10/1/2015

The Sutter Buttes Unit of the BCHC has had a busy year. Due to the lack of snow, the year began early with access to the high country to complete our annual "log out" of 46 miles of the Pacific Crest Trail from Hwy 70 near Belden, North to Hwy 36 near the St Bernard Lodge. This section of the PCT has been adopted by the Sutter Buttes Unit and SBU members work together each year to accomplish the task.

This year we recertified 4 members to operate chainsaws within the National Forest and certified for the first time, 2 additional members for chainsaw operation within the National Forests. Two members were also certified for crosscut saw operation within the National Forests.

The Sutter Buttes Unit also certified 12 members in advanced 1st aid and CPR this year. (this total includes those members required to have 1st Aid and CPR for their saw certification, plus some additional members of the unit.)

Sutter Buttes Unit Members also participated in several additional work/service events. Two members packed in potable water to a youth trail crew, working on repair of trail tread in the Plumas National Forest.

Two Sutter Buttes Unit members located and captured two horses running loose within the Lassen National Forest and facilitated the adoption of said horses through the Tehama County Animal Control.

Members of the Sutter Buttes Unit participated in a "Log out" of trails in the Little Grass Valley recreation area of the Plumas National Forest, at total of 12 miles of trail was cleared of obstacles across the trail.

We have been working with Plumas National Forest management on a project to pack in materials necessary to close off abandon mine shafts located in the Bucks Lake Wilderness Area, it is a work in progress and in the planning stages currently.

Members of the Sutter Buttes Unit negotiated a Trial Horse Camp at the Whitehorse Campground in the Bucks Lake Basin of the Plumas National Forest. The trial albeit only 18 total days, indicated a need and desire on the part of equestrians, for a permanent horse camping opportunity in the Bucks Lake Basin. The area heretofore has not had horse camping available in the area. The Sutter Buttes Unit is and will continue to work with the Plumas National Forest management towards a permanent horse camp in the Bucks Lake Basin.

The Sutter Buttes Unit continues to grow in numbers of members and is already planning for the 2016 season. There seems to be a desire by the membership to have more group outings and camp outs in the coming year.

All in all, it was a very successful and fun year for the members of the Sutter Buttes Unit.



#### **High Country Unit Annual Report 2015**

- A. The unit work details for this year was put on hold for 2015 regarding Modoc Forest Unit. This was in part to personnel change in Modoc Forest Unit. These work details will resume once permanent personnel is in place.
- B. High Country Unit is increasing membership recruitment by targeting all local 4H groups with packing demo and fun rides.

#### SAN JOAQUIN SIERRA ANNUAL REPORT

Prior to all work parties JHA' S were read and explained to all volunteers.

Prior to the start of work each day tailgate safety meetings were conducted with emphasis given to near misses and recent problems with spring trees.

All work was completed with no injuries or accidents.

Our first work party took place at Edison lake area from June 19-26 with 14 participants. We covered approximately 46 miles of trail clearing 3-20", 1-18", 1-16" 4-4", 2-6", 8-2" 17-1" trees along with hours of pruning. One day was spent clearing dead trees from the corrals and rebuilding the corral fences at the Forest service facility. We also cleared all the rotting wood from around the facility.

The next work party took place from July 10-13 with 11 participants. The main purpose of this trip was to install 4 bear boxes at Chamberlain camp. Four boxes were delivered to Voyager camp the first day by four wheel drive. Mules were then used to complete the trip to Chamberlain camp. Special rigging was built to haul the boxes by mule. Approximately forty hours were spent in special training to prepare the mules for this job. Trail had to be cleared in order to accomplish this task. 1-24" 1-16" 1-10" 4-5" and numerous snags were cleared in order for the mule train to complete the route. Boxes were then bolted together and placed in camp. While there we reinforced the overhang on the outhouse with 4x4 post to give more strength for the snow load.

Eight volunteers took part in clearing the trail from wet meadow to Spanish Lake along with four forest service employees on July 27- August 1. All trees were cut by hand as we were in wilderness. The volunteer group was responsible for cutting out 1-36" 2-30" 2-24" 1-22" 3-18" 5-16" 1-14" 4-12" 5-6" 25-4" 40-3" 90-2" 175-1" trees. We also routed approximately 575' of rerouted trail back to the original. Debris was cleared and trees pruned in order to get required setbacks. We have to say many thanks to Mickey and her crew as they were instrumental in helping us to keep the course.

In addition we have had a ride at Tamarack, participated in the Clovis rodeo parade, desensitization clinic, shoot your heart out a trail trial and will have a poker ride in September. We also had a very successful poker ride in March.

July 5-12, 2015 several Redwood Unit members went to the Stanshaw Trail Head for the Marble Mountain Wilderness, Siskiyou County, California. A few members went up early and spent time working on the water system. A seven member, mostly all female crew put in 168 hours working on the water system. Three members also put in six hours clearing logs out of the creek so that the equines could be watered. For the whole weekend a cooking crew headed by Joyce Dollar and assisted by Jim White and Dick Wild cooked meals for the whole event, putting in 60 hours. A lot of the food was prepared using Dutch ovens. Steve Dollar went out on the trails with Beth Fieling from southern California and cleared trees and opened up 10 miles of trails.

On the weekend of July 10-12, several other members rode approximately 246 more riding miles, clearing the trails as needed. Back in camp a crew of members installed 600' for metal "flashing" on the boards of the corrals so that the equines could not chew up the boards. The metal was donated by Design Air of Eureka, CA.

We calculated at least 192 hours of skilled labor in these projects. A very successful event.

### **UNIT NEWS**

#### THE SAN GORGONIO PASS UNIT (SGP)

The SGP Unit membership has faded recently, but rallied a group of committed members for a project at Lake Skinner this summer. Vice President Mandy Picozzi worked to establish good relations with a Resource Manager at the park and had negotiated plans months in advance.

Lake Skinner is nice park south east of Temecula. There was an old ranch on the site many years ago with hay farming and pig raising operations. Grassy rolling hills surround the lake and the largest events nowadays are a big balloon festival and summer concerts. The park has set aside a nice equestrian staging area with hitch rails, water, tables, and porta-potties. Several trails are maintained for hikers and equestrian traffic only. Mountain bikes are not currently allowed on the park trails. The longest trail in the park travels along a canyon of cottonwood trees and rises up on a grassy ridge dotted with Pepper Trees and nice views of a remote section of the park. A picnic table, water trough, and portapotty are at this termination point of this trail. Mandy felt that for the area to be a better lunch stop, that what was really needed was a place to tie a horse or mule; a few hitch rails were in order!

Mandy contacted Christine Moen, Natural Resource Manager for Riverside County Parks and set up a face to face meeting on site and invited President Pete Kriger along as well. Christine was very agreeable to the plan. Christine said she enjoyed working with equestrians as she felt they were a good fit with the park's mission to preserve natural open space and multi-species reserve around the lake. "Horse people just GET IT!", while going on to say that she rallies against the use of mountain bikes on the trails in the park.

The first attempt at this project was preceded by a significant rainstorm. The rainstorm forced closure of the access road and cancelation of the





project. This unfortunate turn of events also resulted in the loss of our partnership with Red Shank Riders and Santa Ana River Units. We couldn't get a reschedule date that would jive with the other

unit's schedules. So the SGP pulled together and got it done ourselves! Mandy requested bids and purchased threaded galvanized pipe, and later Pete welded on horse and mule shoes for tie rings.

The park allowed us to drive a couple of trucks on the narrow access road that is usually closed to park vehicles. There were some steep spots, deep ruts and sandy clay, side hills. It was pretty clear why they wanted to cancel the first date after the rain storm. San Gorgonio Pass had the largest turnout of the year for this event. Six members worked for 3-4 hours. We dug post holes and mixed concrete by hand, and avoided getting stung by bees that had made a nest in a nearby Pepper Tree. After all the work was done, we met for some fine Mexican food in nearby Temecula. Thanks to Mandy, Pete, Rebekah Wan, BJ Heath, Lance and Dianne Stephens.



### Theodore Solomon's Trail

"The Theodore Solomons Trail (TST) is an unofficial 271-mile hiking trail through the Sierra Nevada. From Glacier Point in Yosemite National Park to Horseshoe Meadow in Inyo National Forest just south of Mt. Whitney, the TST is a connection of existing trails that travels through 2 national parks, 3 national forests, and 7 wilderness areas.

Despite the publication of two guidebooks in the 1980's, the TST never gained much popularity. Its lower

elevation, drier climate, and rugged trail could not compete with its more famous cousin to the east, the John Muir Trail. As a result, large portions of the TST have remained unmaintained for many decades and in some areas the trail has disappeared altogether. History

The conception of the TST is credited to Dennis R. Gagnon, who created the route using existing trails through the middle Sierra wildnerness over the course of two summers. Gagnon's original intent was to find a lower elevation alternative to the John Muir Trail, which he found to be too crowded. In 1974, Gagnon published a brochure with a description of the route. He would later publish a guidebook, Guide to the Theodore Solomons Trail.

Before discovering the TST, most hikers are unaware of who Theodore Solomons is and what significant role he has played in the history of the Sierra Nevada. Solomons conceived of and scouted the route that would become the John Muir Trail. At 14 years of age, Solomons looked at the western slope of the Sierra from his home in Fresno and imagined a route that traveled the high Sierra from Yosemite to Mt. Whitney. He would go on to scout the route over two summers from 1894-1895, mapping and naming many features along the way. Evolution Valley and the surrounding mountains were named by Solomons.

When Solomons route was named after John Muir, Solomons stated that he had "no special objection, that the route, when finished was not named after me, nor has any mountain...Muir is a better name to conjure with—for tourist to take the trail for instance—than Solomons. But mine, the idea. The pioneering."

The above is from http://www.theodoresolomonstrail.org, a great resource for the trail.

This trail wends its way from Horseshoe Meadow above Lone Pine through Sequoia National Park to Kings Canyon, crossing the Kings River near Cedar Grove, then climbing over the rugged ridges to the Middle Fork of the Kings River and Simpson Meadow. It then ascents the Tehipite trail to the Crown Valley area, past Courtwright Reservoir, through the John Muir Wilderness, through the Kaiser Wilderness, Ansel Adams Wilderness and Yosemite National Park ending at the Mono Creek Trailhead.



This trail has existing horse facilities along it, lots of grass and water, it traverses wild and scenic country, and is nearly impassable due to hundreds of down trees and sections of missing trail. Tehipite Trail itself is, by all accounts far to dangerous to take stock up or down.

I'd like to see the Back-country Horsemen of California take on the project of making this a viable trail. There are units in the area of the trail, who probably know sections, but, I envision units from throughout the state getting involved, holding work



projects out of local staging areas, bringing in saw crews, both cross cut and chainsaw.

I see the Theodore Solomons Trail as a jewel in the crown of BCHC, usable by both day riders, and packers, both beginner trail riders and experts. I am going to make the trail a major focus area. If you and or your unit want to participate in making the trail a usable reality.
